Welcome and Introductions

Old Business

- Corrections to minutes from meeting on April 16, 2003; various revisions were suggested. Minutes were approved with revisions
- Judith Shrum informed the committee that the Resolution for Administrative Responsibilities for Education Abroad has been approved by University Council and will be forthcoming as a Presidential Policy Memorandum.
- Judith Shrum informed the committee that the Resolution for Administrative Responsibilities for Research and Faculty Endeavors Abroad is a document in progress and asked the committee to give to Rien Visser any input that they may have.
 - ACTION ITEM: Subcommittee to work on this document was formed: Rien Visser (convening), Barry Simmons, LuAnn Gaskill, and Keith Moore.
- Judith Shrum informed committee that the winner of the 2003 Alumni Award for Excellence in International Programs was
 James Marchman. This award as it was originally established was designed for people who do not have access to other
 research and teaching awards for their international work. Award selection committee again this year feels that this award
 needs to recognize education abroad as well as other faculty and staff efforts in international work. Shrum asked UCIP for
 permission to ask the Commission on Outreach and International Affairs for their support in seeking another award. UCIP
 agreed to take it to the Commission.
 - o **ACTION ITEM:** Subcommittee consisting of Dan O'Brien, Kim Beisecker (convening), Judy Snoke, Debbie Day, and John Randolph was formed to develop criteria for additional award(s) and to refine current award.

New Business

- John Dooley gave an overview of the newly appointed task force, Virginia Tech International Strategic Directions Team. This task force has been established to help create, articulate, and initiate a comprehensive and coherent international affairs strategy that will define Virginia Tech's position as a world-class university. Headed by S.K. De Datta, it consists of approximately 22 members with representatives from each college and those who represent and direct critical international program units. Dr. Dooley has asked for a draft report from this task force by April 15, 2004.
- Judith Shrum gave a history of the establishment and structure of UCIP. Initially, it was formed to bring together people who were concerned about international matters as a means to keep each other informed. Over the years, UCIP has assumed a stronger voice. It is time to formalize operations of UCIP by establishing our By-Laws. Shrum suggested that we look at the by-laws for the University Council and the by-laws for the Outreach Council and possibly other by-laws.
 - o **ACTION ITEM:** A subcommittee consisting of S.K. De Datta, Judith Shrum (convening), and Monika Gibson was formed. Subcommittee was asked to bring a proposed structure to our next meeting.
