Engaged Scholar Network Updates

<u>Graduate Certificate Program</u> – Cris Thompson provided a brief update regarding the ongoing efforts of the work group. The committee will meet in the near future to discuss credit and non-credit program possibilities.

<u>University Engagement – Virginia Tech Engaged News website</u> – Diane Deffenbaugh and Rich Matheson encouraged ELC members to forward stories to be included on the website. This site continues to be used to elevate and celebrate engaged scholarship throughout the university.

Carnegie Foundation 2026 Elective Classification for Community Engagement (see slide deck for additional information) Susan shared that nominations were being accepted for individuals to serve on the Leadership Group. She is hopeful that the Commission on Outreach and International Affairs will appoint members to the leadership group during their October 2023 meeting. Expertise is needed in relationship to community partnerships, institution (campus-wide) tracking, monitoring, and assessment, outcomes and impacts, faculty promotion/faculty scholarship, and curriculum. Program Updates

Cathy Sutphin shared information related to the expansion of VCEs Opioid Abatement program.

Cris Thompson and Malle Schilling (Engineering Education) have been selected to participate in the Engagement Scholarship Consortium's Emerging Engagement Scholars Workshop.

Allison Mays announced that a \$450K training proposal from the US EPA Brownfields program. She also shared that the Southwest Center is hosting a Women Impact Virginia (WIV) regional event on Wednesday, September 20th from 9 a.m. – noon. Amy Clark, author of Talking Appalachian: Voice, Identify, and Community, will be the keynote speaker.

Debra Stoudt announced receipt of a \$500K grant from the Andrew Mellon Foundation to create local and regional programming for disability-led arts, culture, reflection, and technology guidance. The three-year project, Just Dis Tech, will involve the launch of an education and arts outreach residency program with artists focused on disability justice. The researchers will also cultivate the emerging inclusive gaming community and establish a Disability Community Technology Center. Ashley Shew, department of science, technology, and society is the project's leader.

Shelly Jobst provided an update to Virginia Tech's Lifelong Learning Institute. Registration is currently open for the Fall Semester. The program has a wide array of course offerings – Demystifying Computer Technology, Creating Beautiful and Tasty Charcuterie Boards, Watercolor, How Anthropology Connects Our Past and Present, Best American Short Stories. About 250 members have registered for 1,000 course seats for the Fall term.

John Provo encouraged the group to learn more about the St. Paul community and the work that faculty, researchers, and students are focusing on in reimaging a historically Black college in rural Brunswick County.

Diane Deffenbaugh provided a brief update regarding the upcoming Women Impact Virginia Summit which will be held at The Hotel Roanoke & Conference Center on October 4th. Keynote speakers include Dr. Winifred Bragg, MD Norfolk VA and Andrea Lynn White, chief of staff to the president and CEO of Genworth Financial, Inc.

Cathy Sutphin shared that the Autism Center is seeking two post-docs or research assistants for the Rural Autism Project. The focus of the project is to build autism centers across the Commonwealth.

Pamela Gilchrist shared reflections from her participation in a STEM computing conference that was recently held in Ghana and thinking about ways to contribute and support educators in that region.




